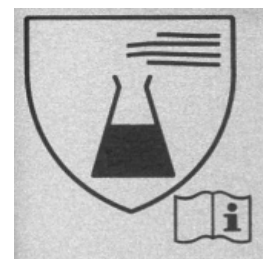

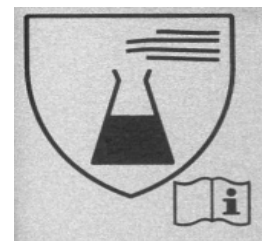

## Question / Problem / Situation:

The EN 13832-3 standard refers to the EN ISO 20347:2011 but this standard is being cancelled.  
How to mark the products when they match with EN 13832-3 with the EN ISO 20347:2022 instead of EN ISO 20347:2011

## Decision to apply:

The manufacturer shall precise in the instruction for use that the product complies the requirements of EN 13832-3 but that the requirements linked with the EN ISO 20347 standard match with the 2022 version and not according to the 2011 version.

Moreover, the product will not be able to be marked with the EN 13832-3. However, the pictogram for chemical resistance could be marked on the product.

This fact is described under the protocol CTC CE C 008.
